About the Health Assessment...

The Humana Health Assessment is a simple questionnaire about your health, exercise habits and lifestyle. It's completely confidential. Humana manages the assessments and the results. St. Vincent receives only aggregate, combined results. No one at St. Vincent sees your personal results. The assessment takes only 10-15 minutes to complete. When you're done, you'll get a report on your health status and the resources and tools available to you.

St. Vincent Is Committed to Your Health

The health assessment is an opportunity for you to identify the choices you're making that improve and maintain good health and the areas where you could improve. St.Vincent does not want to prevent associates from using their benefits. We simply need to get everyone moving toward better health, and requiring a health assessment is a simple and painless way to do that!

Assessment Deadline

If you are currently a benefits-eligible associate electing a St.Vincent medical plan during annual enrollment, the deadline to **complete your assessment is November 30, 2008**. If you do not complete your assessment by the deadline, you will not be covered under our medical plan in 2009, (even if you elected it during annual benefits enrollment or are currently covered).

Completing Your Assessment

Even if you are not currently enrolled in a St. Vincent medical plan, you can complete the assessment. The process is very easy:

- Go online at www.humana.com/hha
- In the drop down box, you'll see a list of employers. Select St. Vincent Health. Inc.
- Enter your first and last name
- Enter your Social Security Number, your date of birth and your zip code
- The assessment will begin on the next screen.

Answer the questions. Your results will be tabulated immediately, and you'll receive your personal results report.

Take the time to review your report. Your results will help you identify the resources you'll need including Health Coaching and help you set goals for the coming year.



You must complete an annual online Humana Health Assessment each year in order to enroll in a St.Vincent medical plan. Your spouse is encouraged to take the health assessment too, but it is not required.

How It Works

The program works like this: get active, monitor your progress, earn Miles, reach Levels, buy stuff or redeem cash. Participants complete an online health snapshot, set goals, receive a pedometer, use gym discounts, log steps and exercise, measure results and EARN rewards. You earn HealthMiles for using your pedometer, for taking your bio-measurements, for filling out a health questionnaire, for taking a fitness assessment and

much more! Depending on how many HealthMiles you log, you can earn rewards of up to \$500 in gift cards at over 50 major retailers!

"Pay to Play" – Your Payroll Deductions

You and St. Vincent share the cost. Your cost is \$2.31 per pay.

Enrolling for HealthMiles

HealthMiles is a wellness program available through Virgin Life Care. You can enroll online through stvincent.humana.com, click on HealthMiles or through the St.Vincent Intranet > Associate Information > SVH Benefits > Wellness programs.



HealthMiles is a voluntary program for benefit-eligible associates. HealthMiles rewards you for getting active. That means you can be rewarded for not only exercise but simply walking around!
